### Description of necessary first aid measures

**Precautions for safe handling**

**Advice on general occupational hygiene** : Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking.  
**Conditions for safe storage, including any incompatibilities** : Store in closed container away from all ignition sources. Handling temperatures should not exceed 175°F (80°C). Wash thoroughly after handling. Odorous and toxic fumes may form from the decomposition of this product if stored at excessive temperatures for extended periods of time. Store in accordance with local regulations. Store in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10).
