Section 4. First aid measures

Description of necessary first aid measures

Section 5. Fire-fighting measures

Extinguishing media

- Spill** : Contain with dikes or absorbent to prevent migration to sewers/streams. Take up small spill with dry chemical absorbent; large spills may require pump or vacuum prior to absorbent. May require excavation of severely contaminated soil.

Section 7. Handling and storage

Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8). Do not get in eyes or on skin or clothing. Do not ingest.
- Advice on general occupational hygiene** : Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking.
- Conditions for safe storage, including any incompatibilities** : Store in closed container away from all ignition sources. Handling temperatures should not exceed 175°F (80°C). Wash thoroughly after handling. Odorous and toxic fumes may form from the decomposition of this product if stored at excessive temperatures for extended periods of time.
